Current dues billed are for the period July 1, 2008 – June 30, 2009; dues are \$295.00. **Please note: dues are payable beginning June 1st and are due by June 30th and are considered delinquent on July 1st.** After June 30th there is a **\$70.00 delinquent fee** that must be sent in with payment. On July 1st, the user's MLS services will be discontinued for nonpayment. You can pay your dues on-line by Telecheck (with Visa or MC). **Note:** On-line payment for GSREIN User Fees will not be available until June 1st.
